She did her best with the material at hand. Two other nine-year veterans receive my thanks -Dave Bartholomew and Peter Russell. I often have received favourable comments on the layout and design of Geoscience Canada, and credit for this goes to Dave. Peter provided those magnificent logos that head our articles. Take the time to browse through past issues and look at them again - you readily appreciate what great talent he has.

Geoscience Canada is known, amongst other things, for its series articles, the first being Facies Models. During my tenure, three series have been in progress and my editors have done yeoman service - Jim Allan followed by Gwilym Roberts (Ore deposits), Nat Rutter (Pleistocene Dating) and Ian McIlraith (Diagenesis). A considerable amount of time is involved in soliciting authors and in getting manuscripts reviewed and revised, and I do appreciate their work.

In a similar vein, I gratefully acknowledge the efforts of my book review editors, Denis St.-Onge, Paul Clifford and Alec Baer, and the editors who ran my Features column - Gordon Winder (Geological Education) and Geri Eisbacher (Active Earth). And to Pat Sheahan who recently joined us as advertising manager, undertaking the difficult job of obtaining advertising revenue for a magazine such as this.

Ward Neale. Not once did his manuscript arrive on time, never, but they were always so good I had to publish them. I think it safe to say that his column was the first article read by most of our subscribers. This issue marks his retirement as well, and it is a major loss for Geoscience Canada.

The many earth scientists, from Newfoundland to British Columbia, who served as my associate editors generating articles, conference reports and book reviews, and serving as reviewers, played a major role in the success of this magazine, and I hope they enjoyed their role.

Finally, to the officers and staff of the GAC, and particularly to Glen Caldwell and John Kramers, I express my gratitude for their constant support and encouragement, especially during those times when I was reaching for the panic button.

To my successor, Andrew Miall, I wish every success. If he gets the support I did it is assured.
