## *Our Contributors/Nos Auteurs*

**Lawrence R. Aronsen**, a graduate of the University of Toronto (Ph.D. 1980), has taught at Simon Fraser University and the University of Victoria. He has recently completed a series of articles on Canada's postwar military-industrial relations and is working on a book entitled *Continentalism and the Cold War: National Security and the Economic Integration of Canada and the United States, 1945-1953*.

**Rainer Bachre** teaches history at Mount Saint Vincent University. He has previously published in *Histoire sociale-Social History* and *Ontario History*. His current research focuses on the social-intellectual nature of nineteenth- and early twentieth-century Canadian asylums as well as Canadian women's history.

**Alan Campbell** did his doctorate at the Centre for the Study of Social History, University of Warwick. He now teaches at the University of Liverpool and has published *The Lanarkshire Miners* (1979) as well as contributing to *Independent Collier: The Coal Miner as Archetypal Proletarian Reconsidered*.

**John Flint** is Professor of History and Director of the African Studies Centre at Dalhousie University. His publications include *Sir George Goldie and the Making of Nigeria* (1960), *Nigeria and Ghana* (1966), and *Cecil Rhodes* (1975). He edited Volume V of the *Cambridge History of Africa* which appeared in 1976. He is a Fellow of the Royal Historical Society and of the Royal Society of Canada.

**Allan Greer** teaches at the University of Maine at Orono. Some of his previous publications were in the fields of literacy and education and popular revolts. He is currently interested in French-Canadian rural society and is finishing a monograph on the Lower Richelieu valley, 1740 to 1840.

**Eric G. Nellis** (Ph.D. British Columbia) is Coordinator and Visiting Assistant Professor of History in the University of Victoria Programme at Agassiz. This article is drawn from his current research into agricultural society and working relationships in provincial Massachusetts. He has published previously in *Labor History* and the *Canadian Review of American Studies*.

**Barrie M. Ratcliffe** is Professor of Contemporary European History and Director of Studies at the Université Laval. He is currently Chairman of the Wallace K. Ferguson Prize Committee of the CHA. He has edited two works, coauthored a book, and contributed two dozen articles to learned journals on his two main research topics: the economics of imperialism and the rise of industrial capitalism in nineteenth-century France.

**Rolande Trempé**, historienne de renommée internationale, est professeur d'histoire à l'université Toulouse—Le Mirail, en France. He is the author of *White Canada Forever: Popular Attitudes, Public Policy and Orientals in British Columbia* and an editor of two recent collections of essays. He has also published several articles in Canadian scholarly journals. At present he is working on a study of courtship and marriage in nineteenth-century English Canada.

**Chris Waters** is a Ph.D. candidate at Harvard University, where he is also an associate of the Center for European Studies. He has published articles and reviews on the history of leisure, youth culture, and English socialism, and is completing a study of socialism and leisure in the later nineteenth century.
