# ABSTRACTS / RÉSUMÉS

## Nineteenth-Century Collective Violence: Toward a North American Context

Scott See

THE STUDY of collective violence has generally reinforced national stereotypes that Canada is a “Peaceable Kingdom” and that the United States is extraordinarily violent. This article assesses the historiography of collective violence since the 1960s and offers specific suggestions for further exploration into Canada’s riotous experiences. Scholars often assume that Canada’s collective violence has been infrequent and less destructive than American episodes. Future research — with a focus on nativism, the social legitimacy of the crowd, religious and ethnic conflict, the entrenchment of powerful state institutions, and vigilantism —might prove otherwise. Regardless, Canadian collective violence will be better understood if it is conceptualized in a North Atlantic context.

L’ÉTUDE des manifestations de violence collective a généralement contribué à renforcer les stéréotypes nationaux selon lesquels le Canada serait un «royaume pacifique» et les États-Unis un pays extrêmement violent. Le présent article jette un regard critique sur l’historiographie de la question depuis les années 1960 et suggère des avenues spécifiques en vue d’une analyse plus approfondie des expériences accumulées par le Canada en matière d’émeutes. Les chercheurs prétendent souvent que les manifestations de violence collective au Canada ont été rares et moins néfastes que celles survenues aux États-Unis. De plus amples recherches sur le nativisme, sur la légitimité sociale des foules, sur les conflits religieux et ethniques, sur l’avènement de puissantes institutions étatiques, et sur le phénomène des vigies privées, pourraient démontrer le contraire. Les manifestations de violence collective au Canada seront néanmoins mieux comprises lorsqu’elles seront articulées dans un perspective nord-atlantique.

# Debunking the Public Health Myth: Municipal Politics and Class Conflict During the Galt, Ontario Waterworks Campaigns, 1888-1890

John S. Hagopian

THIS ARTICLE refutes the assertion that the Galt, Ontario waterworks was built for public health reasons. The two Galt waterworks campaigns (1888 and 1890) are studied in the context of other contemporaneous local events, the most important of which was a moulders' strike in 1889. Popular resistance to businessmen's wants and public support for the striking moulders prompted the formation of a local board of trade and the threat of an industrial exodus from town. The waterworks authorization of 1890 resulted from the victory by businessmen in this overt class struggle. The development of Galt's waterworks reflected economic and political interests far more than public health concerns. The findings refute McLaughlin, and illustrate a novel connection between urban politics, infrastructure development, labour relations, and industrial capitalism.

CET ARTICLE réfute la thèse selon laquelle le système d'aqueduc de la ville de Galt, Ontario, aurait été construit pour des raisons de santé publique. Les deux campagnes entourant la création d'un aqueduc (1888 et 1890) sont étudiées à la lumière de d'autres événements locaux, dont le plus important fut la grève des mouleurs en 1889. La résistance populaire aux demandes des milieux d'affaires et l'appui du public à la grève des mouleurs précipitèrent la formation d'une chambre de commerce et laissa planer la menace d'un exode de capitaux industriels. L'autorisation d'ériger le système d'aqueduc consacrait la victoire des hommes d'affaires dans cet épisode manifeste de lutte de classes. La mise en oeuvre de cet aqueduc était beaucoup plus animée par des intérêts écono-miques et politiques que par des préoccupations de santé publique. Contrairement à McLaughlin, cette recherche met en relief une nouvelle relation entre la politique municipale, le développement des infrastructures, les relations de travail et le capitalisme industriel.

# 'Ruffled' Mistresses and 'Discontented' Maids: Respectability and the Case of Domestic Service, 1880-1914

DOMESTIC SERVICE was an institution of considerable importance for working-class women and middle-class householders in Canada between 1880 and 1914. Service was instrumental in shaping class relations, in large part because it brought the working class directly into the bourgeois home. It was thus an arena where bourgeois and working-class versions of respectability met, and sometimes clashed. Service was essential to the elaboration of a respectable bourgeois lifestyle, and was considered a suitable occupation for working women. yet the peculiar restrictions of the occupation ensured that domestics would often find the trappings of respectability difficult to maintain. Domestics walked a fine line between 'respectability' and 'deviance'; indeed, in the eyes of many, service was an institution that straddled this line.

LE TRAVAIL domestique était une institution d'une importance considérable pour les femmes de la classe ouvrière et les maîtresses de maison de la classe moyenne au Canada, entre 1880 et 1914. En introduisant directement des individus du monde ouvrier dans les résidences de la bourgeoisie, la domesticité exerça un rôle fondamental dans l'élaboration des rapports de classes au sein la société. Par la force des choses, cette institution devint le théâtre où se rencontraient (et parfois s'affrontaient) les conceptions bourgeoise et ouvrière de la respectabilité. Le travail domestique était essentiel au développement du mode de vie respectable de la bourgeoisie, en plus d'être perçu comme un emploi convenable pour une femme. Compte tenu des restrictions propres à ce genre de travail, les domestiques trouvaient souvent difficile de maintenir les standards de respectabilité. Celles-ci évoluaient sur la ligne étroite de démarcation entre la respectabilité et la déviance; en réalité, le travail domestique était, aux yeux de plusieurs, une institution qui chevauchait cette ligne.

# What Kind of Unionism: Struggles Among Sydney Steel Workers in the SWOC Years, 1936-1942

IN LATE 1936 steel worker activists in Sydney launched a new organizing drive at the plant under the auspices of the CIO's Steel Workers Organizing Committee (SWOC). This effort drew the support of steel workers in a way that previous organizing attempts had not. However, the militant and self-reliant traditions of the steel workers collided with the cautious strategies and bureaucratic practices of the appointed SWOC leadership in the United States and Canada. As steel workers at Sydney showed great solidarity in their struggle with DOSCO, they also resisted what they saw as undemocratic and highly accommodationist practices by the union's national and international leadership. The struggles within the union embraced the issues of Canadian autonomy and nationalism as well as rank-and-file union control and the democratic rights of union members. It amounted to a struggle over what type of unionism was to be established within the Canadian steel industry.

VERS LA FIN DE 1936, des ouvriers de la sidérurgie lancèrent aux usines de Sydney une nouvelle campagne de syndicalisation sous le patronage du Steel Workers Organizing Committee (SWOC), affilié au CIO. Cette campagne de recrutement s'attira l'appui des travailleurs de la sidérurgie, comme aucune autre auparavant. Toutefois, les traditions de militantisme et d'affirmation des ouvriers se heurtèrent aux stratégies prudentes et aux pratiques bureaucratiques des dirigeants attitrés du SWOC aux Etats-Unis et au Canada. En plus de témoigner d'une grande solidarité durant leur conflit avec la compagnie DOSCO, les ouvriers de Sydney s'opposaient à ce qu'ils percevaient comme des pratiques antidémocratiques et conciliantes de la part de direction nationale et internationale de l'union. Cette lutte intra-syndicale touchait autant à des questions reliées au nationalisme et à l'autonomie des sections canadiennes, qu'à des questions reliées au contrôle hiérarchique des militants de la base et aux droits démocratiques des membres de l'union. Au fil des événements, on en vint même à se demander quel type de syndicalisme était le plus approprié à l'industrie canadienne de la sidérurgie.

# 'Cowering Women, Combative Men?': Femininity, Masculinity and Ethnicity on Strike in Two Southern Ontario Towns, 1964-1966

IN AUGUST 1964, the southern Ontario local 523 of the United Electrical and Radio Machine Workers led some 450 female auto-parts workers onto the picket-line. A year later, the same union local led over 1,200 male steelworkers in a strike against the Steel Company of Canada. In both cases, Italian immigrants joined with their non-Italian co-workers in a show of class solidarity. Italian men framed their decision to strike in terms of a manly duty as the family's decision maker and breadwinner; Italian women assumed the role of aggressive labour militant with relative equanimity, while the more outwardly militant Italian men expressed considerable personal uncertainty and fear even while they engaged in a public display of cross-ethnic class solidarity. The paper explores how gender, class and ethnicity interact to influence the dynamics of labour militancy in the two strikes, though it also gives due consideration to the structural factors that helped to determine the outcome of both strikes.

EN AOÛT 1964, le local sud-ontarien 523 des United Electrical and Radio Machine Workers mobilisa environ 450 ouvrières de pièces d'automobiles sur les lignes de piquetage. L'année suivante, cette même section locale fut à l'origine de la grève qui opposait plus de 1200 ouvriers de la sidérurgie à la Steel Company of Canada. Dans les deux cas, les travailleurs immigrants italiens se joignirent à leurs confrères non-italiens dans un élan de solidarité de classe. Les ouvriers italiens formulèrent leur décision de faire la grève en termes de responsabilité masculine, étant donné leur statut de pourvoyeur et de chef de famille; à l'inverse des militants italiens les plus en vue qui exprimaient énormément de craintes et de doutes personnels (et ce, malgré les manifestations publiques de solidarité inter-ethnique), les ouvrières italiennes exerçaient leur rôle de militante acharnée avec une relative sérénité. Cet article examine comment les notions de genre, de classe et d'ethnicité ont interagi pour influencer la dynamique du militantisme ouvrier lors de ces deux grèves; l'exposé porte également une certaine attention aux facteurs structuraux qui ont aidé à déterminer l'issue des deux conflits.



# LABOUR / LE TRAVAIL

*L/LT* is a bilingual semi-annual review dedicated to the broad, interdisciplinary study of Canadian labour history. Holding to no rigid position on the definition of labour, the Editorial Board hopes to foster imaginative approaches to both teaching and research in labour studies through an open exchange of viewpoints.

The Board feels that Canadian history lacks a sufficient understanding of the lives of workers. Productive human energy has played a vital role in the development of Canadian society. Our common life has also been richly endowed with the cultural contributions of generations of working men and women. It will be the constant endeavour of *L/LT* to rectify an all too general Canadian ignorance of these legacies.

The Board welcomes the submission of articles dealing with the following: trade and industrial union organization; social and cultural aspects of the lives of workers; questions relating to labour in politics and the economy; the impact of labour problems on local communities and on various ethnic, cultural and national groups; biographical treatments of union leaders or radicals associated in some way with the labour movement; labour ideologies of reform or revolution; and comparative studies of labour in other countries which shed light on the Canadian situation.

Articles should be submitted to the *L/LT* office in duplicate. If they have been prepared on a word processor or computer, please provide appropriate information and include a disc. Upon receipt they are reviewed by the editor and if the article fits the journal's editorial mandate and is felt to be of reasonable quality, a file is opened and the manuscript is sent out for review. The referees generally include both members and non-members of the editorial board. When the referees' reports are received, the editor compiles them, makes a final decision upon the manuscript based on the referees' views, and reports to the author. The author always receives the readers' reports and is invited to respond to them. Articles may be rejected, accepted without revision (rarely), accepted with revision (frequently), or accepted subject to substantial revision and resubmission to one of the original readers to insure that the revisions are adequate. Upon acceptance of an article authors are asked to sign our permission to print form.

La revue *L/LT* se consacre à l'étude interdisciplinaire de l'histoire des travailleuses et des travailleurs du Canada. Les articles sont publiés dans les deux langues officielles du pays. Le Comité de rédaction n'établit aucune définition particulière du *travail* et désire plutôt que la revue serve de carrefour afin de permettre un fructueux échange d'opinions entre les diverses écoles d'interprétation.

La rédaction est convaincue que l'histoire canadienne ne peut se passer d'une connaissance du monde ouvrier dans toutes ses dimensions. La société canadienne n'aurait pu se développer sans la contribution de générations de travailleuses et de travailleurs. Pour remédier aux oubliés du passé, *L/LT* se propose de faciliter la reconstitution de cette histoire et de la rendre plus accessible.

Afin d'atteindre ces buts, nous sollicitons des manuscrits sur des aspects du monde ouvrier tels que: les syndicats de métier et d'entreprises, les non-syndiqués(ees), les conditions de vie des travailleuses(euses), les mouvements radicaux et réformistes liés au monde ouvrier, l'impact politique, économique et social du syndicalisme, les idéologies ouvrières, ainsi que les études sur les travailleuses et travailleurs de tous les pays dans la mesure où elles contribueront à la connaissance du milieu canadien.

Les textes doivent être soumis en deux exemplaires. Les articles rédigés sur ordinateur ou sur machine de traitement de texte doivent être accompagnés d'une copie sur support électronique et des informations nécessaires. Les textes sont soumis à un comité de rédaction. S'ils sont conformes aux principes éditoriaux et aux exigences de qualité de la revue, un dossier est ouvert et le manuscrit est envoyé au comité de lecture. Celui-ci inclut des membres du comité de rédaction ainsi que des lecteurs ou lectrices externes. Sur réception des rapports d'évaluation, le rédacteur de la revue prend une décision finale basée sur les critiques reçues et la transmet à l'auteur. Les personnes qui soumettent des textes reçoivent toujours les rapports de lecture et sont invitées à y répondre. Les articles peuvent être refusés, acceptés sans révision (rarement), acceptés avec révision (fréquemment), ou acceptés après révision de fond et l'avis de l'un des membres du premier comité de lecture. Lorsqu'un texte est accepté pour publication, les auteurs signent l'autorisation de publication.
