BRUCE TRIGGER is a Professor of Anthropology at McGill University and author of a number of publications dealing with Canada's Native Peoples, including The Children of Aataetentsic: A History of the Huron People to 1660 and Natives and Newcomers: Canada's 'Heroic Age' Reconsidered. He is co-editor of the forthcoming North American volume of the Cambridge History of the Native Peoples of the Americas. After receiving her B.A. and her M.A. from the University of Western Ontario and her Ph.D. from Clark University, GAIL CAMPBELL was a post-doctoral fellow at the University of New Brunswick, where she began work on the electoral system in 19th century New Brunswick. A member of the Department of History at Saint Mary's University, COLIN HOWELL is currently one of the co-editors of the Canadian Historical Review and has recently published A Century of Care: A History of the Victoria General Hospital in Halifax, 1887-1987. After receiving her B.A. from Mount Allison and her M.A. from Saint Mary's University, MICHAEL SMITH entered the doctoral programme at Memorial University of Newfoundland. Author of a recent article on "Graceful Athleticism or Robust Womanhood: The Sporting Culture of Women in Victorian Nova Scotia, 1870-1914" in the Journal of Canadian Studies, she is the first person to have both an article and a review article appear in the same issue of Acadiensis. SUZANNE MORTON completed her B.A. at Trent and her M.A. at Dalhousie before entering the Ph.D. programme at Dalhousie; her research focuses on working class activism in early 20th century Halifax. Formerly a Fisherman's Union organizer in Nova Scotia, FRED WINSOR is currently a Ph.D. candidate in history at Memorial University of Newfoundland, where he is working on a history of health and safety in Newfoundland's offshore industries. A member of the Department of Public International Law at the University of Edinburgh, WILLIAM C. GILMORE recently published a book on Newfoundland and Dominion Status. After receiving his Ph.D. from the University of Toronto, BROOK TAYLOR joined the Department of History at Mount St. Vincent University; he is a specialist on 19th century Canadian historiography and has a book on that subject forthcoming. A graduate of the military history programme at the University of New Brunswick, MARC MILNER worked for the history section of the Department of National Defence before returning to his alma mater; he has published a study of the Canadian role in the battle of the North Atlantic during World War Two. CLARENCE KARR has taught in every region of Canada and currently is in the Department of History at Malaspino University College in Naniamo, B.C.; he specializes in Canadian intellectual history and has published many articles on this subject.
