Our Contributors / Nos auteurs

Ruth Compton Brouwer is an associate professor of history at King's College, University of Western Ontario. The author of *New Women for God: Canadian Presbyterian Women and India Missions, 1876-1914*, she is now researching the careers of three Canadian professional women in twentieth-century colonial settings.

Malcolm Bruce Colcleugh is a Fulbright Doctoral Candidate at Tulane University in New Orleans. His ongoing dissertation research examines popular, guerilla resistance to the American invasion and occupation of Mexico between 1846 and 1848.

Peter Goddard is assistant professor of History at the University of Guelph, where he teaches the history of Christianity, intellectual change in the 17th century, and the early modern encounter between Europe and the New World. He is currently working on a book on early modern French Catholic missionary activity and the development of cultural anthropology in the seventeenth century.

Michael A. Hennessy is an Assistant Professor of Naval and Maritime History, at the Royal Military College of Canada, Kingston. His published work on maritime history focuses on Canadian naval policy, shipbuilding, and merchant shipping policy since 1945. He is the new editor of *Argonauta*, the newsletter of the Canadian Nautical Research Society.

James A. Leith, Professor of History at Queen's University, has been a member of its history department since 1961 and was its chair from 1968 to 1973. An expert on eighteenth century France, his special interests are in the Enlightenment, the French Revolution, and the comparative history of modern revolutions. He is the author of numerous articles and has edited or written several books, including *Space and Revolution: Projects for Monuments, Squares and Public Buildings in France, 1789-1799* (1991). He was elected to the Royal Society of Canada in 1983.

L. Richard Lund was, until recently, a fifth year PhD candidate in history at York University, but he has left the programme for a year in order to pursue a Bachelor of Education degree. His doctoral dissertation, which will be completed after Teacher's College, is entitled, "Unempoyment and the Canadian Welfare State, 1941-71."

Jean Manore is a graduate of the University of Ottawa. While doubling as a part-time professor and research consultant, she continues to pursue her academic interests in aboriginal issues and the environment. Currently, she is revising her dissertation for publication.

Donald A. Wright completed his BA at Mount Allison University and his MA at McGill University. He is currently a doctoral candidate in history at the University of Ottawa. His dissertation is a study of the professionalization of history in English Canada, 1919-1945.
