Jason Patrick Bennett is a graduate of Simon Fraser University in Canadian history, and is currently a participant in the Living Landscapes Project co-sponsored by Okanagan University College and the Royal British Columbia Museum. Presently, he is working on a comparative history of landscape and the colonial project in the Pacific Northwest.

Albert Churella is a Senior Lecturer in the Department of History at The Ohio State University, and author of *From Steam to Diesel: Managerial Customs and Organizational Capabilities in the Twentieth-Century American Locomotive Industry* (Princeton, 1998).

Robert Cupido is a doctoral candidate in the history department at Dalhousie University. His dissertation examines the relationship between public commemoration and the formation of political identity in Canada between the wars.

Chris Dummitt is a doctoral candidate in the Department of History at Simon Fraser University. His current research explores the place of violence and risk in men's daily lives in post-WW II Vancouver.

Magda Fahrni is a doctoral candidate in history at York University. Her dissertation examines Montreal families in the wake of the Second World War.

Robin S. Gendron is a PhD Candidate in the Department of History at the University of Calgary. He is currently researching his dissertation examining the evolution of Canadian relations with French-speaking parts of Africa from 1945 to 1968.

Steve Hewitt is writing a history of RCMP security intelligence operations on the campuses of Canadian universities.
