EDITOR'S REPORT

Kealey's report emphasized the potentially disastrous implications of the SSHRC'S forthcoming "review" of grants to scholarly publications, as early as 1984. That body's suggestion that a switch to computerization of materials be considered as a means of effecting cutbacks in funding poses a most serious threat to our and other journals.

PROPOSAL RE STREET RAILWAY WORKERS' PROJECT - Bob Babcock

Babcock outlined his own work in the Maritimes on street railwaymen, ca. 1890-1930; and urged the members to consider other community projects in a comparative perspective.

The possibility of a special issue of *Labour /Le travailleur* on this topic was mooted. The members expressed an interest in exploring the question further.

REPORT OF 1981 PROGRAMME COMMITTEE - Craig Heron

The report, which is in the President's hands, stresses the desirability of improving the work of the committee by various means. Following discussion it was:

PROGRAMME THEME FOR 1983 (Vancouver)

Several suggestions were put forward: "Work and Family"; Street Railway employees; commemoration of the 100th Anniversary of the Trades and Labour Congress of Canada. After some discussion, there was a consensus that, regrettably, the time remaining for working out the programme (approx. 12 weeks) did not permit us to make a firm commitment on this question. The members agreed to do their best, however, to address the "Work and Family" theme, hopefully with a regional (British Columbia) emphasis.

REPORT ON INTERNATIONAL CONGRESSES — Stanley Ryerson

Ryerson gave the members present an informal outline of the work of the International Committee on Historical Sciences, 1980-5, in preparation for the Stuttgart Congress, on the impact of technological change on society and social movements. Interested scholars and members were urged to contact the following individuals: Stanley Ryerson (UQAM); Joanne Burgess (UQAM); Greg Kealey (Memorial), the Canadian contact persons.
