The Internationale Tagung der Historiker der Arbeiterbewegung has selected the themes for its 1988 conference, which will be held in Linz, 12-17 September 1988. The conference will focus on problems of the political formation of the working class and the labour movement and ecology. The themes for 1989 will be decided this year, and the proposals of the international consultative board are the Second International in the history of the international labour movement, and the labour movement and technological change as historical problem. The board has also suggested two themes for 1990: the international trade union movement in the years after the Second World War, until circa 1950, and the labour movement, religion, and the church as methodological problem.
