## Annual Meeting Canadian Committee on Labour History University of British Columbia, Vancouver, 3 June 2008

#### **CALL TO ORDER**

#### **MINUTES OF 2007 MEETING**

That the minutes of the 2007 Annual Meeting, as published in *Labour/Le Travail*, 60 (Fall/automne 2007), 351-7, be approved.

#### **PRESIDENT'S REPORT**

David Frank thanked Greg Kealey for chairing last year's annual meeting in his absence. As instructed by that meeting, a letter thanking Memorial University for their generous support of *Labour/Le Travail* for more than 25 years was sent to the university's Dean of Arts. A reply from the Historic Sites and Monuments Board to CCLH's letter of 1 July 2007 raising concerns about the Board's limited recognition of labour history and workers was received. The Board advises that Parks Canada will develop a framework study on labour history. Much of the executive's activity throughout the past year was devoted to the logistical issues of the move to Athabasca University. David Frank welcomed Kathy Killoh and Linda Kadis of AU Press to the meeting and expressed his appreciation for their efforts during the transition.

#### **EUGENE FORSEY PRIZES**

David Frank reported that the Forsey Prizes are announced in Vol. 61 of *Labour/Le Travail* and will also be announced by the Canadian Historical Association later today. He thanked past members for their service and circulated a sign-up sheet inviting members to serve on the committees. A discussion on the format and deadline for submissions followed. It was agreed to establish a slightly later deadline than 1 June but also seek to continue to reach decisions by Labour Day. On the question of moving to electronic rather than paper submissions to minimize photocopying and shipping costs, concerns were expressed that this would download additional work to jury members, several of whom stated they would prefer to read submissions, especially theses, in a paper format. It was agreed to accept submissions in either format.

Bryan Palmer read from a letter from Joan Sangster regarding ongoing work to put the Forsey Prizes on a more permanent financial footing. Joan

reported progress on the matter and expects to announce a final resolution at the next meeting through the creation of an endowed fund.

David Frank thanked Nicole Lang for updating the French text for the Prize notices, which are published in the journal and on the CCLH website.

#### **CONSTITUTIONAL AMENDMENT**

м/s/с (David Frank, Alvin Finkel):

To amend the CCLH Constitution, Article Vl, b, to read as follows:

"Vice-Presidents: Two Vice-Presidents shall assist the President in her/his duties and substitute for the President if she/he is unable to perform the duties of the presidency".

The rationale for the amendment was to strengthen regional and language representation and to add an additional member to share executive responsibilities. A Notice of Motion had been duly given and published as part of the minutes in *Labour/Le Travail*, 60 Fall/automne (2007).

#### **EDITOR'S REPORT**

Bryan Palmer reported that the move of *Labour/Le Travail* from Memorial University to Athabasca University was almost complete, publication of the journal had been kept on schedule and things were working fine. The move has taken three years with considerable effort devoted to protecting the security of former staff at Memorial, ensuring unionized printing and managing the transition to online access of the journal. He expressed thanks to everyone at Athabasca University for making the move a successful one, especially AU Press staff Kathy Killoh and Linda Kadis. AU Press has prepared flyers to promote the journal. Submissions have increased in number, notably from younger scholars, and online hits to the journal are very high. The editor encouraged members to subscribe, reminding them of the very favourable rates available to graduate students. He thanked those who had read or submitted manuscripts.

Of significant concern for the future of the journal is the funding shift of the Social Sciences and Humanities Research Council of Canada (SSHRC) from a formula based on number of pages to number of articles published (\$850.00 per article). This is problematic for publishing long and substantive articles as *Labour/Le Travail* does. Of additional concern is the definition of article; SSHRC will need to be persuaded that notes, reviews, etc, should be funded. The anticipated funding for next year is \$27,000.

### TREASURER'S REPORT

Greg Kealey presented the Treasurer's Report showing a good financial year despite the costs of moving to Athabasca University. The report was accepted by members present.

CCLH is considering two manuscripts, having published *Confrontation*, *Struggle and Transformation: Organized Labour in the St. Catharines Area* by Carmela Patrias and Larry Savage in 2007 and *The Struggle against Wage Controls: The Saint John Story, 1975–1976* by George Vair the year before. Greg Kealey announced that the RCMP Security Bulletins are to be digitized by the UNB Electronic Text Centre and will be available online in a searchable format.

Question: Where is the existing stock of the CCLH books?

Answer: It has been moved to Athabasca University.

#### **REPORT ON CCLH WEBSITE**

Jeff Taylor reported that the CCLH website had been updated in the move from the server at Memorial University to the server at Athabasca University. One notable change to the website is that the new portal for Canadian labour and working-class history has become the link to further labour history resources. This portal (http://www.workinghistories.ca ) was developed as part of the "Work and Society in Historical Perspective" research cluster initiative, which was funded by the Social Sciences and Humanities Research Council of Canada. Jeff encouraged members to continue to alert him to labour history resources that should be identified on the site. Bryan Palmer expressed thanks to Donica Belisle for managing the CCLH LISTSERV.

### CCLH WORKSHOP 2009

There was CCLH workshop this year because of the Labor and Working Class History Association (LAWCHA) meeting in Vancouver 6-8 June 2008 hosted in cooperation with the Pacific-North West Labour History Association.

Rhonda Hinther extended an invitation on behalf of the Workers' Heritage Committee of the Ottawa and District Labour Council to host the CCLH Workshop in 2009, which will mark the 90th anniversary of the labour revolt of 1919. Among the proposed activities is a tour of the new Workers' Heritage Centre Museum to be located in a working-class home dating from 1870 in Vanier, which they are developing in conjunction with the City of Ottawa. Rhonda Hinther volunteered to act as the liaison person for the workshop.
