## CONTRIBUTORS / COLLABORATEURS

**Tracey Adams** is an Associate Professor in the Department of Sociology at the University of Western Ontario. Her research generally explores the link between work and social inequality in historical context. Most of her research focuses on the development of professions and the acquisition of professional power historically in Canada.

**Kendra Coulter** is an Assistant Professor in the Department of Sociology, Anthropology and Criminology at the University of Windsor. Her studies of gender and economic inequalities have appeared in *Studies in Political Economy*, *Just Labour*, and the *Journal of Women, Politics and Policy*. She worked in retail for six years without the benefits or protection of a union.

**Lois Jackson** (PhD) is in the Faculty of Health Professions and is Acting Scientific Director of the Atlantic Health Promotion Research Centre at Dalhousie University. She studies the relationship between work and health, social inequities and health, addictions, and qualitative methods of inquiry.

**Suzanne Mills** is an Assistant Professor in the School of Labour Studies and the School of Geography and Earth Sciences at McMaster University. Her research examines labour union engagement with Aboriginal peoples and diversity in resource-based employment. She has published articles in *Geoforum*, the *Canadian Journal of Native Studies*, and the *Labour Studies Journal*.

**Barbara Neis** (PhD) is a University Research Professor in Sociology and a Senior Research Associate at the SafetyNet Centre at Memorial University where she

does research on work and health with a focus on rural and remote occupations.

Public Employees in 1977, her life was transformed by working with him. Her 30-year work history at CUPE was primarily in research and education, starting as a Research Assistant, becoming Research Director and Managing Director of the National Services and Union Development departments.

**Julia Temple Newhook** has a PhD in Sociology from Memorial University and is a former research assistant at the SafetyNet Centre for Occupational Health and Safety Research at Memorial. Her doctoral research examined gender, work and health among primary and elementary school teachers in Newfoundland.
